

**TOYOTA HALF-COURT SHOT PROMOTION  
OFFICIAL RULES**

- 1. NO PURCHASE NECESSARY TO ENTER OR TO WIN. A PURCHASE WILL NOT INCREASE YOUR ODDS OF WINNING. ALL FEDERAL, STATE, LOCAL AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.**
- 2. ELIGIBILITY.** Promotion is open to persons 18 years of age or older at time of entry who are legal US residents residing within the state of Oregon and Western Washington, except employees (former and current), agents, successors and assignees of Trail Blazers Inc. ("TBI" or "Sponsor"), Toyota Motor Sales, U.S.A., Inc. ("TMS/USA"), the Pacific Northwest Toyota Dealers Association ("PNTDA"), SCA Promotions Inc., the National Basketball Association ("NBA") and its Member Teams, NBA Properties Inc., Rip City Management LLC, Rip City League LLC, Blazer5 Gaming LLC, and each of their respective affiliated companies, subsidiaries, and advertising or promotional agencies, and the family members of, agents, successors, or assigns of, and any persons domiciled with such persons, all of whom are not eligible for entry. The following are also not eligible to enter: (a) current or former professional or semi-professional basketball players or coaches; (b) current or former high school or collegiate basketball players or coaches who have played or coached at either the high school or collegiate level anywhere in the world within the past five (5) years (includes freshmen, junior varsity and varsity); and (c) persons who have been chosen as a previous contestant/winner in this ½-court shot promotion during the past twenty-four (24) months.
- 3. ENTRY.** Entry in the Toyota ½ Court Shot promotion (the "Promotion") will begin on October 13, 2023 and will end at 11:59 p.m. PT on March 21, 2024 ("Entry Period"). LIMIT OF ONE (1) ENTRY PER PERSON DURING THE ENTRY PERIOD, REGARDLESS OF METHOD OF ENTRY. There are three (3) ways to enter as follows: (1) Enter online by visiting the Toyota ½ Court Shot official registration page on [www.trailblazers.com](http://www.trailblazers.com), completing all required information, and following all instructions. Submit your entry by clicking on the "SEND" button. You must complete the entire form in order to enter the Promotion online. By entering online, each entrant further agrees to be bound by the terms relating to the use of the website, including its [Privacy Policy](#); (2) Fill out an entry form at the Toyota Tip-Off Show "Enter to Win" display set on the main concourse of the Moda Center during a Trail Blazers home game occurring on or before March 21, 2024; or (3) Send a post card with your name, address, city, state, zip and phone number to: Toyota ½ Court Shot, One Center Court, Ste. 200, Portland, OR 97227. All entries must be received no later than 11:59 p.m. PT on March 21, 2024. No mechanical reproductions permitted. Sponsor will not be responsible for incomplete, lost, late, postage-due, misdirected or illegible entries, or for failure to receive entries due to transmission failures or technical failures of any kind, including, without limitation, malfunctioning of any network, hardware or software, whether originating with sender or Sponsor. In the event of a dispute, all electronic entries will be deemed to have been submitted by the owner of the electronic account from which they were sent. For these purposes, an electronic account holder shall mean the natural person assigned to such account by the Internet access provider, online service provider or other organization responsible for assigning electronic addresses for the domain associated with such electronic account. Any questions regarding the number of entries submitted or the owner of an electronic account shall be determined by Sponsor in its reasonable discretion. Sponsor reserves the right to disqualify any entries by persons determined to be tampering with or abusing any aspect of the Promotion as solely determined by Sponsor. In the event any aspect of the Promotion is compromised by a virus, non-authorized human intervention, tampering or other causes beyond the reasonable control of Sponsor which corrupts or impairs the administration, security, fairness or proper operation of the Promotion, Sponsor reserves the right in its sole discretion to suspend, modify or terminate the Promotion.
- 4. CONTEST/PRIZE/VEHICLES.** During the Entry Period, Sponsor will choose at random one (1) entrant from all eligible entries received up to forty-eight (48) hours prior to each of the following thirteen (13) designated Trail Blazers regular season home games to be a contestant: 11/5/23; 11/17/23; 12/16/23; 12/17/23; 12/29/23; 1/29/24; 1/31/24; 2/10/24; 2/27/24; 3/11/24; 3/13/24; 3/22/24; and 3/23/24. **Entrants drawn to be a potential contestant must be able to attend the respective game for which their entry was drawn in order to be confirmed as a contestant and attempt the half-court shot the game or the opportunity will be forfeited and another entrant will be randomly drawn.** Sponsor reserves the right in its sole discretion to change the foregoing game schedule without notice. Entries not selected in a random drawing will be rolled over to the next random drawing up to the final random drawing of the Promotion. Odds of being drawn as a potential contestant in the Promotion will depend on the number of eligible entries received up to the date of each respective random drawing. Each of the thirteen (13) confirmed contestants will receive a prize of two (2) tickets to attend the Trail Blazers home game at which their respective contest attempt (described below) will take place (exact seat location to be determined in Sponsor's sole discretion at time of award). Total approximate retail value of the prize is \$250.00 (exact value may vary based on the then-current market rate for the respective game and seat location). Transportation, parking, food, beverages and all other incidental expenses associated with acceptance and use of such prize and participation as a contestant are not included and will be the sole responsibility of contestant and/or his/her guest, as applicable. No contestant shall be permitted any practice, warm up or qualifying shots at any time after notification and acceptance of selection as a contestant, nor will any contestant be selected to participate in this ½-court promotion on more than one occasion during the past twenty-four (24) months. The confirmed contestant may not choose another person to participate on his/her behalf in the contest attempt.

During the game for which the contestant has been chosen to participate in the contest, contestant will have one (1) attempt to make a ½-court shot in compliance with the provisions of these Official Rules to win a new 2023 or 2024 Toyota-branded vehicle (exact year of vehicle will be determined by PNTDA at time of prize award based on availability at the specific dealership; specific make and model of vehicle to be determined by contestant spinning a wheel as described below). The vehicles on the wheel and their respective approximate manufacturer's suggested retail value ("MSRP") will be as follows: Grand Highlander XLE (\$44,670); Tundra SR5 (\$50,550); Highlander Hybrid LE (\$43,155); Highlander LE (\$41,755); Toyota Crown XLE (\$41,045); Prius XLE e-AWD (\$32,495); Sienna LE (\$39,185); Tacoma SR5 (\$38,055); Camry Hybrid XLE (\$33,745); Camry XLE (\$32,570); 4Runner SR5 (\$42,265); Venza LE (\$34,930); Corolla Cross XLE (\$29,015); Corolla Cross Hybrid SE (\$29,290); RAV4 XLE Limited (\$31,385); RAV4 Hybrid Limited (\$39,780); Corolla XSE (\$27,000); and Corolla Hatchback XSE (\$26,655). MSRP for each specific vehicle may vary based on exact year of vehicle awarded and specific details and amenities included; and in each instance will be subject to availability at time of prize award and at PNTDA and the dealership that was featured at the respective game or an alternative dealership designated and authorized by PNTDA, in its reasonable discretion. The depiction of the prize award in any advertising or promotional materials or physical display may not reflect the actual vehicle delivered to the winner. There will be no

less than one (1) slot per vehicle on the wheel for any contest. The total number of vehicle slots for each designated contest attempt will be twenty-four (24).

To determine which Toyota-branded vehicle the contestant will be attempting the shot for, the contestant will spin the wheel and whichever vehicle space it lands on, that will be the vehicle the contestant will be attempting the ½-court shot to win if such contestant successfully makes the shot pursuant to the terms contained herein. To be considered as an eligible spin of the wheel, it must complete no less than two (2) full revolutions in order for the vehicle space landed on to be considered as the prize for making the attempted shot. Spins completing less than two (2) revolutions are ineligible and contestant must spin the wheel again prior to attempting the shot. Once contestant spins the wheel, the wheel must not be touched or interfered with by anyone or anything. If the wheel is touched or interfered with during a spin, the contestant will be disqualified. The contestant will have only one chance to spin the wheel, unless the wheel completes fewer than the two (2) revolutions as specified above. Once the wheel completes two (2) revolutions, the contestant may not spin the wheel again.

Each potential contestant chosen and confirmed as a contestant to attempt the ½-court shot must comply with all applicable health & safety requirements in effect on the date of the game, complete an affidavit of eligibility, and a liability and publicity release (except where prohibited by law) before attempting the ½-court shot. Each contestant will also be required to complete the "Contestant Agreement to Participate" provided by Sponsor's prize indemnifier before attempting the ½-court shot. Failure to sign and return the affidavit, release or the Contestant Agreement to Participate, or to comply with any term or condition of these Official Rules, may, at the sole discretion of Sponsor, result in disqualification and the forfeiture of such person's interest in the ticket prize and/or the opportunity to attempt the shot.

The contestant must attempt to make the ½-court shot using a Sponsor-provided NBA-regulation basketball (or one of equivalent specifications) through the NBA-regulation basketball hoop of the target goal. The rim of the target hoop will be not less than ten (10) feet above the floor. The contestant must attempt the ½-court shot from behind the demarcation line measured forty-three (43) feet from the backboard of the target goal. The contestant will have only one (1) attempt to make the ½-court shot in compliance with all provisions of these Official Rules. An attempt will be deemed to have occurred when the basketball has been released by the contestant. No part of the contestant's body or clothing may come in contact with or cross the demarcation line prior to releasing the ball. In order to be counted as a successful ½-court shot, the basketball must pass completely through the target hoop on the fly, from the point of release from the contestant's hand(s), without coming in contact with the ground, any person, or any surface other than the backboard or hoop, and would otherwise constitute a successful shot scoring a goal under NBA regulations.

- 5. CONTESTANT/WINNER NOTIFICATION AND ACCEPTANCE.** Each entrant who is randomly selected to have the opportunity to participate as a contestant will be notified by phone at the number provided on the entry form within forty-eight (48) hours before the start time of their respective game and must answer the phone call and provide verbal acceptance to Sponsor's representative to be a potential contestant and be able to attend the respective game for which their entry was drawn. Only after completion of all required information and documents (as set forth in these Official Rules), and verification by Sponsor, the confirmed contestant will be provided with two (2) game tickets and the opportunity to attempt the ½-court shot at their respective game. If a potential contestant does not answer the phone call from Sponsor's representative, is unable to provide verbal acceptance, is not fully vaccinated, or declines to participate as a contestant, then another entrant shall be selected by random drawing. If a potential contestant who has already received game tickets is disqualified prior to the contest for any reason, Sponsor reserves the right to randomly select another potential contestant prior to the contest from those persons in attendance at the respective game, regardless of whether such person submitted an official entry. Any contestant may waive their right to receive a prize. Prizes are nonassignable and nontransferable. No substitutions allowed, except that prizes and individual components of prize package are subject to availability and Sponsor and/or PNTDA, as applicable, reserves the right to substitute prizes of equal or greater value. Each contestant is solely responsible for reporting and payment of any and all federal, state, local, and municipal taxes associated with participation in the Promotion and use of any prize, including, but not limited to, transportation, lodging, parking and any incidental expenses.

Any winner of a prize vehicle shall be responsible for all taxes, license, title and registration fees or other costs, including without limitation any travel or transportation costs, associated with transferring and/or acceptance of the prize vehicle.

PNTDA shall not be responsible for delays in availability of a prize vehicle. PNTDA, however, shall use all reasonable efforts, subject to availability, to make the prize vehicle available within one hundred eighty (180) days after receipt of all required documentation. A vehicle winner shall bear all risk of loss or damage to the prize vehicle after winner has taken possession of the prize vehicle. A winner must personally retrieve the prize vehicle from the respective dealership within thirty (30) days of written notification of delivery and must present adequate personal identification and evidence of legally required insurance (or the prize vehicle may be forfeited).

A prize vehicle will be delivered solely with the express written limited warranties set forth in the respective prize vehicle's applicable Owner's Guide, which warranties shall run for the term set forth in said guide.

Except where prohibited, participation in the Promotion constitutes the contestant's consent to the publication, dissemination and use of such person's name, photograph, image, likeness and voice by Sponsor, TMS/USA, PNTDA, SCA Promotions, their designees, the NBA and its Member Teams, and/or NBA Properties, Inc., in any media at any time for any purpose without any additional compensation to, permission from or inspection by such contestant. If any contestant makes the ½-court shot, such contestant agrees to execute all necessary and requested documents, including without limitation, the "Winner's Affidavit and Release", as requested by Sponsor and Sponsor's prize indemnifier and agree to provide a copy of a government issued identification card containing a photo of the contestant/winner. Should the Promotion be terminated prior to the end of the stated Entry Period, Sponsor reserves the right to award any prize based on the entries received before the termination date.

- 6. HEALTH & SAFETY REQUIREMENTS.** Due to the uncertainty related to any health and/or safety situation, including but not limited to COVID, admission to the Moda Center at the time of the respective game may be subject to all then-current safety and health requirements and policies put in place by the Rose Quarter, which may be updated from time to time as necessary or required, in

the sole determination of any of Sponsor, the Rose Quarter, the National Basketball Association, the State of Oregon, local health authorities, and/or any other applicable governmental authority. Each contestant and such contestant's guest must acknowledge and agree to comply with all then-current health & safety requirements prior to and during the game, and use of the ticket prize awarded in the Promotion, participation as a contestant, and attendance for the entire game will be conditioned on such compliance. No contestant nor such contestant's guest will be provided a credit or refund for an unused ticket due to non-compliance with the foregoing requirements and/or denial of entry to the Moda Center for any reason.

- 7. PARTICIPATION.** By participating in the Promotion, including acceptance and/or use of any prize, each participant agrees to be bound by these Official Rules and the decisions of Sponsor and SCA Promotions. Guest of a contestant will not have any independent rights to prize or any portion thereof and such guest must accompany contestant at all times during use of the prize. Any guest of a contestant who is not 18 years of age on the date of the respective game shall require that contestant be the parent/legal guardian of such minor guest, unless prior written consent of such minor guest's parent/legal guardian has been obtained by contestant. Each contestant and his/her guest agree to abide by all rules and policies of the NBA and the Moda Center. Sponsor and management personnel of the Moda Center reserve the right to remove or to deny entry to any contestant and/or his/her guest if any such person violates any policy, rule or engages in a disruptive manner, or with intent to abuse, threaten or harass any other person during the experience. Solely for purposes of compliance with the terms and conditions provided in these Official Rules and use of a portion of the prize, guest of a contestant will be deemed solely as a participant, regardless of whether such guest submitted an official entry, and shall in no manner be considered as a potential contestant.
- 8. CONTESTANT/WINNER RELEASES.** By participating in the Promotion, including acceptance and/or use of any prize, such participant releases TMS/USA, PNTDA, SCA Promotions Inc., Trail Blazers Inc., Rip City Management LLC, the NBA and its Member Teams, NBA Properties Inc., any other promotional sponsors, and each of their respective affiliated and parent companies, and subsidiaries, directors, officers, employees, representatives, partners and agents from any liability whatsoever for any claims, costs, injuries, losses or damages of any kind arising out of or in connection with the Promotion or with the acceptance, possession or use of any prize (including, without limitation, any claim, cost, injury, loss or damage related to any personal injury, death, damage to, loss or destruction of property, right of publicity or privacy, defamation or portrayal in a false light).
- 9. LIMITATIONS OF LIABILITY.** By entering the Promotion and accepting any prize, each participant agrees that (1) any and all disputes, claims, and causes of action arising out of or in connection with the Promotion, or any prize awarded, shall be resolved individually without resort to any form of class action; (2) any claim, judgment or award shall be limited to actual out-of-pocket costs incurred, including costs associated with entering the Promotion, but in no event attorney's fees; and (3) under no circumstances will any participant be permitted to obtain any award for, and each participant hereby waives any and all rights to claim, punitive, incidental or consequential damages and any and all rights to have damages multiplied or otherwise increased and any other damages, other than damages for actual out-of-pocket expenses.
- 10. CONSTRUCTION.** All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of any participant in the Promotion, and/or Sponsor, shall be governed by, and construed in accordance with the laws of the State of Oregon, without giving effect to any choice of law or conflict of law rules or provisions (whether of Oregon, or any other jurisdiction) that would cause the application of the laws of any jurisdiction other than Oregon. The invalidity or unenforceability of any provision of these Official Rules shall not affect the invalidity or unenforceability of any other provision. In the event that any such provision is determined to be invalid or otherwise unenforceable, these Official Rules shall be construed in accordance with their terms as if the invalid or unenforceable provision was not contained therein. Each participant/contestant agrees that should any dispute arise between such contestant and Sponsor's prize indemnifier, such dispute must be submitted to binding arbitration in accordance with the rules of the American Arbitration Association. The venue for such arbitration shall be Portland, Oregon.
- 11. SPONSOR.** The Toyota ½ Court Shot promotion is sponsored by Trail Blazers Inc., located at One Center Court, Suite 200, Portland, OR 97227. Ticket portion of each prize is provided by TBI. If a vehicle is won by a contestant, PNTDA will provide prize fulfillment in accordance with these Official Rules and such other details or provisions as required by PNTDA and/or the respective dealership, as determined in their sole discretion.

By submitting an entry and participating in the Promotion, each participant is voluntarily providing contact information to Sponsor, which includes such entrant's/participant's express consent to provide such information to PNTDA and their respective designees or third-party fulfillment company, and accepts and agrees to be bound by Sponsor's decisions regarding the selection of any potential contestant and any other aspect of the Promotion, which in each instance shall be final and binding in all respects. Sponsor will not be responsible for any typographical, printing or other inadvertent errors in these Official Rules or in any other materials relating to the Promotion. Sponsor reserves the right to modify or update these Official Rules without notice at any time during the Promotion, as may be deemed necessary or required, as determined in Sponsor's sole and reasonable discretion.

- 12.
