

OFFICIAL RULES
AXIOM ECO-PEST CONTROL TICKET GIVEAWAY

- 1. NO PURCHASE NECESSARY TO ENTER OR TO WIN. A PURCHASE WILL NOT INCREASE YOUR ODDS OF WINNING. ALL FEDERAL, STATE, LOCAL AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.**
- 2. ELIGIBILITY.** The Axiom Eco-Pest Control Ticket Giveaway (the “Sweepstakes”) is open to persons 18 years of age or older at the time of entry who are legal US residents residing in the state of Oregon or Western Washington, except employees of the Axiom EPC of Oregon LLC d/b/a Axiom Eco-Pest Control (“Axiom”), Trail Blazers Inc. (“Sponsor”), Rip City Management LLC (“RCM”), Rip City League LLC, Blazer5 Gaming LLC, the National Basketball Association (“NBA”) and its member teams, NBA Properties Inc., and each of their respective affiliated companies, subsidiaries, and advertising or promotional agencies, and the family members, agents, successors or assigns of, and any persons domiciled with, such employees, are not eligible for entry.
- 3. ENTRANTS CAN RECEIVE UP TO ONE (1) ENTRY PER HOUSEHOLD PER ENTRY PERIOD REGARDLESS OF METHOD OF ENTRY FOR COMPLETING EITHER (A) OR (B) AND TWENTY-FIVE (25) ADDITIONAL ENTRIES FOR EACH REFERRAL TO SPONSOR’S “GENERAL PEST PROTECTION” OR “MOSQUITO, FLEA, AND TICK” PLANS, OR DIRECTLY SWITCHING TO OR SIGNING UP FOR SPONSOR’S “GENERAL PEST PROTECTION” OR “MOSQUITO, FLEA, AND TICK” PLANS. By entering online, each entrant agrees to be bound by the terms relating to the use of the website, including the privacy policy located at [Privacy Policy](#); or (B) on a 3"x5" card or piece of paper print your full name, address, telephone number (including area code), e-mail address (where applicable), and mail it postage paid addressed as follows: “Axiom Eco-Pest Control Ticket Giveaway Entry,” c/o Trail Blazers Inc., One Center Court, Suite 200, Portland, OR 97227, or drop it off at the Trail Blazers business office during regular business hours at the foregoing location. All entries must be received by 11:59 p.m. PT prior to the last day of the respective Entry Period, regardless of method of entry. No mechanical reproductions permitted. In the event of a dispute, all electronic entries will be deemed to have been submitted by the owner of the electronic account from which they were sent. For these purposes, an account holder shall mean the natural person assigned to such electronic account by the Internet access provider, online service provider or other organization responsible for assigning such electronic account. Any questions regarding the owner of an electronic account shall be determined by Sponsor in its sole, reasonable discretion. Sponsor will not be responsible for incomplete, lost, late, misdirected or illegible entries, or for failure to receive entries for any reason, any of the equipment or programming associated with or utilized for an entry, or by any technical or human error that may occur due to transmission failures or technical failures of any kind, including, without limitation, malfunctioning of any network, hardware or software, whether originating with entrant or Sponsor.
- 4. PRIZE/ODDS.** Each confirmed winner will receive two (2) courtside tickets to a 2025-2026 Portland Trail Blazers regular season home game (exact game date and seat location will be determined in Sponsor’s sole discretion based on availability at the time of award; prize excludes transportation, lodging, parking, food, beverages and all incidentals), Axiom pest service, and an Axiom & Trail Blazers cobranded t-shirt. Approximate retail value of prize is \$3,000.

The prize has no cash value, any difference between the stated value and the actual value at time of award will not be provided. No substitution, cash equivalent or transfer of either prize will be permitted except at Sponsor’s sole discretion to offer a prize of comparable or greater value. Each winner will be solely responsible for all incidental costs or expenses, including reporting and payment of any federal, state, local, and municipal taxes, transportation, parking and meals, relating to acceptance and/or use of their respective prize. Each winner acknowledges and agrees

that their respective prize awarded is personal to such winner and may not be sold, resold, auctioned, bartered, assigned exchanged, placed in commerce, transferred, given away, donated or otherwise conveyed. A violation of these restrictions shall revoke such winner's license, and their prize will not be honored.

Solely for purposes of compliance with the terms and conditions provided in these Official Rules and use of Portland Trail Blazers game tickets, the guest of the respective ticket winner will be deemed as an entrant/participant in the Sweepstakes, regardless of whether such guest submitted an official entry. The guest of the winner may be required to sign a release and waiver to receive benefits of the prize or any portion thereof, as applicable or determined by Sponsor in its sole discretion. The winner must be the parent/legal guardian of a guest under the age of 18 on the date of the game unless winner has received prior written consent from such guest's parent/legal guardian. The guest of the winner will not have any independent rights to the prize or any portion thereof and guest must accompany winner at all times during use of the prize. Sponsor and management personnel of the Moda Center reserve the right to remove or to deny entry to winner and/or winner's guest if such person violates the previous restrictions or engages in a disruptive manner, or with intent to abuse, threaten or harass any other person during the experience. Each of the winners and winner's guest agrees to abide by all rules and policies of the Rose Quarter and RCM and are subject to removal for noncompliance or unruly behavior.

Due to the uncertainty related to any health and/or safety situation, including but not limited to COVID-19, admission to enter the Moda Center at the time of the Portland Trail Blazers game will be subject to all then-current safety and health requirements and policies put in place by the Rose Quarter, and RCM, including those related to use of any ticket, as any of such may be updated from time to time as necessary or required, in the sole determination of any of either Sponsor, the Rose Quarter, the State of Oregon, local health authorities, and/or any other applicable governmental authority (collectively, the "Health & Safety Requirements"). Winner and winner's guest must acknowledge and agree to comply with all then-current Health & Safety Requirements prior to and during the concert, and use of the prize and attendance for the entire concert will be conditioned on such compliance. Neither winner nor winner's guest will be provided a credit or refund for an unused ticket for any reason, including but not limited to if due to non-compliance with the above requirements, and/or denial of entry to the Moda Center for any reason.

WINNER NOTIFICATION AND ACCEPTANCE.** There will be two (2) winners randomly drawn on or about the first business day after the last day of each Entry Period as follows: November 12, 2025; December 15, 2024; February 2, 2026; March 2, 2026 and April 6, 2026 (each a "Drawing Date"). Non-winning entries from any Drawing Date will not be rolled over or eligible for any other Drawing Date. Each potential winner will be notified by phone or e mail as provided on their submitted entry within two (2) business days of the respective Drawing Date. In the event a potential winner does not respond within two (2) business days of attempted notification or declines the prize, another potential winner will be randomly chosen from the remaining eligible entries received during the respective Entry Period. Each confirmed winner is solely responsible for any and all federal, state, and local income taxes, and unless specifically stated herein, is solely responsible for any additional expenses which may be associated with participation in the Sweepstakes, and acceptance and/or use of a prize, including but not limited to hardware, software or any other technical requirements for use of prize. Sponsor is not responsible for and will not pay or in any way compensate any winner for taxes or expenses associated with participation in and/or acceptance or use of a prize in this Sweepstakes. Sponsor reserves the right to disqualify persons found tampering with or otherwise abusing any aspect of this Sweepstakes as solely determined by Sponsor. The invalidity or unenforceability of any provision of these rules shall not affect the invalidity or unenforceability of any other provision. In the event that any such provision is determined to be invalid or otherwise unenforceable, these rules shall be construed in accordance with their terms as if the invalid or unenforceable provision was not contained therein.

By entering/participating in this Sweepstakes, each participant is voluntarily providing their contact information to Sponsor, which includes such participant's express consent to provide such information to their respective designees, third-party fulfillment company, if applicable, and accepts and agrees to be bound by the terms, conditions and provisions contained in these Official Rules and the decisions of Sponsor, which decisions will be final in all regards. Sponsor reserves the right to modify or update these Official Rules without notice at any time during the Sweepstakes as may be deemed necessary or required, as determined in their sole and reasonable discretion.
