

**OFFICIAL RULES**  
**PORTLAND TRAIL BLAZERS SILVER SEATS GIVEAWAY PRESENTED BY COORS LIGHT**

1. **MUST BE 21 OR OLDER TO PARTICIPATE. NO PURCHASE NECESSARY TO ENTER OR TO WIN. ALL FEDERAL, STATE, LOCAL AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.**
2. **ELIGIBILITY.** The Portland Trail Blazers Silver Seats Giveaway Presented by Coors Light (“Sweepstakes”) is open to legal U.S. residents ages 21 or older at time of entry who reside within the state of Oregon or Western Washington. Employees of Molson Coors Beverage Company USA LLC (“Coors Light”), Trail Blazers Inc. (“TBI” and together with Coors Light referred to hereinafter as “Sponsor”), Rip City Management LLC, the National Basketball Association and its member teams, NBA Properties Inc., and each of their respective parent and affiliated companies, subsidiaries, advertising and promotional agencies, and the immediate family and household members of each of the foregoing employees are not eligible to enter, participate or win a prize in this Sweepstakes.
3. **ENTRY.** This Sweepstakes will begin on November 17, 2025, and will end at 11:59 p.m. Pacific Time (“PT”) on March 9, 2026 (the “Entry Period”). By entering online, each entrant agrees to be bound by the terms relating to the use of the website, including the privacy policy located at [Privacy Policy](#); or (B) Scan the QR code found within the Moda Center arena via center hung scoreboard on the following select game nights: November 19, 2025; November 26, 2025; December 18, 2025; December 23, 2025; January 5, 2026; February 20, 2026; and March 8, 2025, provide all required contact information and submit your entry; or (C) Go to the Portland Trail Blazers Instagram page (@trailblazers), click on the sign up button in such giveaway post to be directed to <https://www.nba.com/blazers/silver>, locate the Sweepstakes advertisement, click on the link to enter, provide all required contact information and submit; or (C) a 3"x5" card or piece of paper print your full name, address, telephone number (including area code), e-mail address (where applicable), and mail it postage paid addressed as follows: “Portland Trail Blazers Silver Seats Giveaway Presented by Coors Light Entry,” c/o Trail Blazers Inc., One Center Court, Suite 200, Portland, OR 97227, or drop it off at the TBI’s business office during regular business hours at the foregoing location. All entries must be received by 11:59 p.m. PT on March 9, 2026, regardless of method of entry. No mechanical reproductions permitted. **LIMIT OF ONE (1) ENTRY PER PERSON.** In the event of a dispute, all electronic entries will be deemed to have been submitted by the owner of the electronic account from which they were sent. For these purposes, an account holder shall mean the natural person assigned to such electronic account by the Internet access provider, online service provider or other organization responsible for assigning such electronic account. Any questions regarding the owner of an electronic account shall be determined by Sponsor in its sole, reasonable discretion. Sponsor will not be responsible for incomplete, lost, late, misdirected or illegible entries, or for failure to receive entries for any reason, any of the equipment or programming associated with or utilized for an entry, or by any technical or human error that may occur due to transmission failures or technical failures of any kind, including, without limitation, malfunctioning of any network, hardware or software, whether originating with entrant or Sponsor.
4. **PRIZE/ODDS.** On March 10, 2026, two (2) entrants will be selected by random drawing from all entries received during the Entry Period, who pending verification and eligibility confirmation by Sponsor, will be awarded the following respective prize based on the order their entry was randomly drawn.

*First Draw:* Four (4) Coors Silver Seats tickets (Section 207, Row O, Seats 1-4) to the March 25, 2026, Portland Trail Blazers vs. Milwaukee Bucks regular season home game at Moda Center in Portland, Oregon and two (2) parking passes (prize excludes transportation, lodging, food, beverages and all incidentals). Prize must be used in its entirety during the March 25, 2026 game. Approximate retail value of prize is \$502.

*Second Draw:* Four (4) Coors Silver Seats tickets (Section 207, Row O, Seats 1-4) to the April 2, 2026, Portland Trail Blazers vs. New Orleans Pelicans regular season home game at Moda Center in Portland, Oregon and two (2) parking passes (prize excludes transportation, lodging, food, beverages and all incidentals). Prize must be used in its entirety during the April 2, 2026 game. Approximate retail value of prize is \$502.

Neither of the above prizes have any cash value, any difference between the stated value and the actual value at time of award will not be provided. No substitution, cash equivalent or transfer of either prize will be permitted except at Sponsor’s sole discretion to offer a prize of comparable or greater value. Each winner will be solely responsible for all incidental costs or expenses, including reporting and payment of any federal, state, local, and municipal taxes, transportation, parking and meals, relating to acceptance and/or use of their respective prize. Each winner acknowledges and agrees that their respective prize awarded is personal to such winner and may not be sold, resold, auctioned, bartered, assigned exchanged, placed in commerce, transferred, given away, donated or otherwise conveyed. **Prizes Use Terms:** Solely for purposes of compliance with the terms and conditions provided in these Official Rules and use of Portland Trail Blazers game tickets, the guests of the respective ticket winner will be deemed as entrants/participants in this Sweepstakes, regardless of whether such guests submitted an official entry. release and waiver to receive benefits of the prize or any portion thereof, as applicable or determined by Sponsor in its sole discretion. Winner and winner's guests must acknowledge and agree to comply with all then-current Health & Safety Requirements prior to and during the game, and use of the prize and attendance for the entire game will be conditioned on such compliance. Neither winner nor winner's guests will be provided a credit or refund for an unused ticket for any reason, including but not limited to if due to non-compliance with the above requirements, and/or denial of entry to the Moda Center for any reason.

**Odds:** The odds of winning a prize will depend on the number of eligible entries received during the Entry Period. There is one (1) prize available for award for each respective drawing in this Sweepstakes as set forth above.

5. **WINNER NOTIFICATION AND ACCEPTANCE.** Each potential winner will be notified by telephone and/or email as provided on their method of entry within forty-eight (48) hours of the drawing. In the event contact with a potential winner is not confirmed within two (2) days of attempted notification, or if a potential winner declines to receive their prize, another entrant will be randomly chosen. Due to the specific date for use of the ticket prize, if Sponsor is unable to confirm a winner after three (3) attempts, Sponsor reserves the right to not award the ticket prize to any entrant in this Sweepstakes or to combine the first and second prizes to award. Each confirmed winner is solely responsible for any and all federal, state, and local income taxes, and unless specifically stated herein, is solely responsible for any additional expenses which may be associated with participation in this Sweepstakes, and acceptance and/or use of a prize, including but not limited to hardware, software or any other technical requirements for use of prize. Sponsor reserves the right to disqualify persons found tampering with or otherwise abusing any aspect of this Sweepstakes as solely determined by Sponsor. The invalidity or unenforceability of any provision of these rules shall not affect the invalidity or unenforceability of any other provision. In the event that any such provision is determined to be invalid or otherwise unenforceable, these rules shall be construed in accordance with their terms as if the invalid or unenforceable provision was not contained therein.

Sponsor reserves the right to modify or update these Official Rules without notice at any time during this Sweepstakes as may be deemed necessary or required, as determined in their sole and reasonable discretion.
