

OFFICIAL RULES
REBOUND SUITE GAME NIGHT EXPERIENCE SWEEPSTAKES

- 1. NO PURCHASE NECESSARY TO ENTER OR TO WIN. A PURCHASE WILL NOT INCREASE YOUR ODDS OF WINNING. ALL FEDERAL, STATE, LOCAL AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.**
- 2. ELIGIBILITY.** The Rebound Suite Game Night Experience Sweepstakes (the “Sweepstakes”) is open to persons who are 18 years of age or older, who are legal US residents residing in the state of Oregon or Western Washington, except employees of Rebound Orthopedics and Neurosurgery (“Rebound”), Trail Blazers Inc. (together with Rebound collectively referred to herein as “Sponsor”), Rip City Management LLC, Rip City League LLC, Blazer5 Gaming LLC, the National Basketball Association (“NBA”) and its Member Teams, NBA Properties Inc., and each of their respective parent companies, affiliates, subsidiaries, and advertising or promotional agencies, and the family members, agents, successors or assigns of, and any persons domiciled with, such employees, are not eligible for entry. None of Facebook, LLC, Instagram, nor any of their respective parent companies, subsidiaries, or affiliates, are a sponsor, administrator or associated in any manner with any aspect of this Sweepstakes.
- 3. ENTRY.** The Sweepstakes will begin on November 20, 2023 and will end at or about 5:00 p.m. Pacific Time (“PT”) on February 14, 2024 (the “Entry Period”). There are three (3) ways to enter the Sweepstakes: (1) go to the Contest page on www.trailblazers.com or the Rebound website www.reboundmd.com and click on the link to the Rebound Suite Game Night Experience Sweepstakes ad which will take you to the entry form, provide all required contact information and follow the instructions to submit your entry; or (2) click on the Rebound Suite Game Night Experience Sweepstakes ad on Facebook or Instagram, each of which will take you to the entry page, provide all required contact information and submit. By entering on social media or online, each entrant agrees to be bound by the [NBA Terms of Use](#) of the [Trail Blazers website](#), Facebook or Instagram sites, as applicable, including each respective site’s Privacy Policy; or (3) on a 3"x5" postcard or piece of paper print your full name, address, telephone number (including area code), e-mail address (where applicable), and mail it postage paid addressed as follows: “Rebound Suite Game Night Experience Sweepstakes Entry,” c/o Trail Blazers Inc., One Center Court, Suite 200, Portland, OR 97227, or drop it off at the Trail Blazers business office during regular business hours. All entries must be received by 5:00 p.m. PT on February 14, 2024, regardless of entry method. In the event of a dispute, all electronic entries will be deemed to have been submitted by the owner of the electronic account from which they were sent. For these purposes, an account holder shall mean the natural person assigned to such electronic account by the Internet access provider, online service provider or other organization responsible for assigning such electronic account. Any questions regarding the owner of an electronic account shall be determined by Sponsor in its sole, reasonable discretion. Sponsor will not be responsible for incomplete, lost, late, misdirected or illegible entries, or for failure to receive entries for any reason, any of the equipment or programming associated with or utilized for an entry, or by any technical or human error that may occur due to transmission failures or technical failures of any kind, including, without limitation, malfunctioning of any network, hardware or software, whether originating with entrant or Sponsor.

Sponsor reserves the right to disqualify any entries by persons determined to be tampering with or abusing any aspect of the Sweepstakes as solely determined by Sponsor. In the event any aspect of the Sweepstakes is compromised by a virus, non-authorized human intervention, tampering or other causes beyond the reasonable control of Sponsor which corrupts or impairs the administration, security, fairness or proper operation of the Sweepstakes, Sponsor reserves the right in its sole discretion to suspend, modify or terminate the Sweepstakes. Should the Sweepstakes be terminated prior to the stated expiration date, Sponsor reserves the right to award the prizes based on the entries received before the termination date. All submissions/entries become the property of Sponsor and will not be returned.

- 4. DRAWING; PRIZE; ODDS.** On February 17, 2024, four (4) entrants will be chosen by random drawing from all eligible entries received during the Entry Period who, after confirmation by Sponsor of eligibility, verification and compliance with the provisions in these Official Rules, will be awarded a prize consisting of: two (2) suite entry tickets to the March 8, 2024 Portland Trail Blazers vs Houston Rockets regular season home game at Moda Center in Portland, Oregon (exact suite location to be determined by Sponsor in its sole discretion at time of award), including food and non-alcoholic beverages which will be provided in the suite during the game and a Meet and Greet with the Rebound doctors who provide medical services to the Portland Trail Blazers players (prize excludes transportation, parking, incidentals and any and all related taxes and fees). Prize must be used in its entirety during the March 8, 2024 game. Approximate total retail value of prize is \$575.

Prize has no cash value; any difference between the stated value and the actual value at time of award will not be provided. Each winner and such winner's guest must be able to attend the March 8, 2024 game; no substitutions allowed, except that prize is subject to availability and Sponsor reserves the right to substitute a prize of equal or greater value. Each winner agrees that the prize awarded is personal to such winner and may not be sold, resold, auctioned, bartered, assigned, exchanged, placed in commerce, transferred, given away, donated, or otherwise conveyed, without the express written consent of Sponsor.

The guest of a winner will not have any independent rights to prize or any portion thereof and guest must accompany their respective winner at all times during use of the prize. A violation of any of the foregoing restrictions shall revoke such winner's license, and the prize experience may be terminated early and/or not honored, without refund or credit provided. Sponsor and management personnel of the Moda Center reserve the right to remove or to deny entry to a winner and/or a winner's guest if such person violates the previous restrictions or engages in a disruptive manner, or with intent to abuse, threaten or harass any other person during the experience. Due to the uncertainty related to any health and/or safety situation, including but not limited to the COVID-19 pandemic, admission to enter the Moda Center at the time of the Trail Blazers game will be subject to all then-current safety and health requirements and policies put in place by the Rose Quarter as provided on the Rose Quarter website at www.rosequarter.com, which may be updated from time to time as necessary or required, in the sole determination of any of Sponsor, the Rose Quarter, the National Basketball Association, the State of Oregon, local health authorities, and/or any other applicable governmental authority. Each winner and such winner's guest must acknowledge and agree to comply with all then-current health & safety requirements prior to and during the game, and use of the prize and attendance for the entire game will be conditioned on such compliance. No winner nor guest of a winner will be provided a credit or refund for an unused ticket due to non-compliance with the foregoing requirements and/or denial of entry to the Moda Center for any reason.

Solely for purposes of compliance with the terms and conditions provided in these Official Rules and use of the prize, the guest of a winner will be deemed as an entrant/participant in the Promotion, regardless of whether such guest submitted an official entry. The guest of a winner may be required to sign a release and waiver to receive benefits of the prize or any portion thereof, as applicable or determined by Sponsor in its sole discretion. - 5. WINNER NOTIFICATION AND ACCEPTANCE.** Each potential winner will be notified by telephone and/or email as provided on their method of entry within seventy-two (72) hours of the drawing. In the event contact with a potential winner is not confirmed within seventy-two (72) hours of attempted notification, or if a potential winner declines to receive the prize, another entrant will be randomly chosen. Due to the limited timeframe for award of the prize, Sponsor reserves the right to limit the attempts to award a prize from the eligible entries and confirm a winner to three (3) attempts, after which (i) Sponsor may randomly select a winner from those persons in attendance at the March 8, 2024 game, or (ii) the prize may not be awarded to any person, as determined in Sponsor's reasonable discretion. Each confirmed winner is solely responsible for any and all federal, state, and local income taxes, and unless specifically stated herein, is solely responsible for any additional expenses which may be associated with participation in the Sweepstakes, and acceptance and/or use of the prize, including but not limited to hardware, software or any other technical requirements for use of prize. The invalidity or unenforceability of any provision of these rules shall not affect the invalidity or unenforceability of any other provision. In the event that any such provision is determined to be invalid or otherwise unenforceable, these rules shall be construed in accordance with their terms as if the invalid or unenforceable provision was not contained therein.

None of Facebook, LLC, Instagram, nor any of their respective parent companies, subsidiaries, nor affiliates are a sponsor, administrator nor associated in any manner with any aspect of this Sweepstakes.

By participating in the Sweepstakes, each participant is voluntarily and expressly providing contact information to each co-Sponsor, which includes such participant's express consent to provide such information to their respective designees, third-party fulfillment company, and accepts and agrees to be bound by the terms, conditions and provisions contained in these Official Rules and the decisions of Sponsor, which decisions will be final in all regards. Sponsor reserves the right to modify or update these Official Rules without notice at any time during the Sweepstakes as may be deemed necessary or required, as determined in their sole and reasonable discretion.
