





#### Trail Blazers Foundation Fund - PLAY Grant

The Trail Blazers are dedicated to positively impacting the lives of individuals from communities that have been historically underserved or marginalized, with a particular focus on youth where they live, learn, and play. Through the PLAY grant, the Trail Blazers Foundation Fund of the Oregon Community Foundation supports organizations throughout Oregon and SW Washington that are getting kids from underserved and marginalized communities and their families active.

Please note: Organizations may only apply for one Trail Blazers Foundation Fund grant type (LIVE Greener, LEARN or PLAY) per year.

One of the ways the Trail Blazers Foundation invests in our region is by providing grants to organizations that fit our mission. When it comes to our PLAY focus area, these are organizations that are getting youth active. We know that active kids do better - in school and in life - and that inactivity is pervasive in our communities. Through this grant program, TBFF supports organizations that provide opportunities and inspire kids to get moving.

Organizations with a mission or major program focused on getting youth and their families active are invited to apply for up to \$25,000 of annual funding. After an initial year of support, organizations may be selected to receive an additional year of funding, for a total of up to \$50,000 over two years.

## **Funding Priorities**

TBFF prioritizes PLAY grants for organizations that:

- Focus on getting youth and their families active as their core mission or as a major program of their organization (priority will be given to organizations providing basketball programming)
- Serve populations disproportionately impacted by social, economic and/or racial injustices and inequities in Oregon (listed in alphabetical order):
  - o Black, Indigenous, Latinx and people of color
  - Immigrants and/or refugees
  - People experiencing disabilities,
  - People living on low incomes
  - People living in under-resourced communities and/or communities lacking in critical infrastructure
  - People who are homeless/unsheltered
  - People who identify as LGBTQIA+
  - o Survivors of domestic violence and/or child abuse
- Represent geographic diversity throughout the state of Oregon and SW Washington
- Are able to show, quantitatively or qualitatively, that the existence of their program has made a difference in the lives of youth served
- If applying as a basketball or other sports league, must hold 501c3 nonprofit status, and more than 50% of the league's service population is considered low-income







#### **Guidelines**

- Organizations with a mission aligned with the PLAY funding priorities may apply for general
  operating/unrestricted support; organizations with a major program aligned with the PLAY
  funding priorities may apply for funding to support that program
- Priority will go to programs serving predominantly children from underrepresented and marginalized communities
- Organizations may apply for up to \$25,000 in funding per year
- Organizations must be providing services in Oregon and SW Washington
- Organizations may request funds for travel/transportation provided they are essential components of the organization or program in question
- Organizations should apply for program expenses rather than youth scholarships to programs. Scholarship funding will not be considered unless it is the core purpose of the organization.
- If you represent a PTO, PTA, or school, please instead apply for a grant from the TBF Take it to the Court for Education program in the Fall by visiting <a href="www.trailblazers.com/takeittothecourt">www.trailblazers.com/takeittothecourt</a> to complete an application
- Organizations may request funds for sport-related capital projects like basketball courts and hoops.

## Eligibility

# Geographic Focus and Organizational Requirements

Because the Trail Blazers Foundation raises money from fans across the state, it is important for us to give back to communities throughout Oregon.

Applications are accepted from organizations that are a 501(c)(3) public charity; an IRC 7871 Federally-Recognized Indian Tribe; or a government entity (such as a City Parks & Recreation department).

#### Frequency of Application

- You may apply for one grant type (LIVE Greener, LEARN or PLAY) from the Trail Blazers Foundation Fund per year.
- You may receive only one grant from the Trail Blazers Foundation Fund per year. Nonprofits are still eligible to participate in the 5050 raffle via the Trail Blazers Foundation.
- Applying to Trail Blazers Foundation Fund does not preclude you from applying to other Oregon Community Foundation grant programs.
- This grant program will <u>NOT</u> be open to applications in 2025. Organizations that receive funding this year (2024) will receive a request for information in spring 2025. If they continue with programming, remain in good standing, and additional funding is available, they will be granted a second year of funding. This means applications for *LIVE Greener*, *LEARN*, and *PLAY* grants will not be accepted again until spring 2026.

## Not Eligible for Funding

- Organizations which discriminate based on age, ethnicity/race, political affiliation, religion, sexual orientation, gender, gender identity, physical or other disability, or national origin
- Individuals (including scholarships, stipends, fellowships, and personal assistance)
- Scholarship funding, unless it's the core purpose of your organization. If you'd like to provide underserved youth access to your programming, please apply to the program expenses rather than a scholarship amount
- Research or project planning activities
- Basketball teams
- Schools
- Endowments, memorials, budget deficits, or fundraising activities
- Religious organizations whose programs do not have a secular and community focus
- Lobbying, political, or fraternal activities







- Organizations that intend to regrant the funds awarded
- Projects and events that occur prior to a TBFF grant award
- Leagues that are serving less than 50% low-income youth

## **Application Process & Deadline**

All applications should be submitted using the online grants system, MyOCF on April 2, 2024 by 5:00pm. Late applications will not be considered. Award decisions will be made and communicated by June 30. Organizations awarded a grant should expect to receive funds in early July.

# **Grantee Reporting and Renewal Opportunity**

An impact report is due 9 months after a grant is awarded. It is submitted electronically and will serve as a request for a second year of support for your efforts. The opportunity for awarding renewal funding is at the discretion of Trail Blazers Foundation Fund staff and advisors: additional funding is not guaranteed.
